### CONDITIONS

As a user of an Aspen Skiing Company (ASC) season pass, I hereby agree to comply with the following regulations. These regulations apply to alpine and Nordic skiing and snowboarding.

- I understand **THIS PASS IS NONREFUNDABLE AND UNUSED DAYS HAVE NO RSVP VALUE. I have been informed of my option to purchase season pass insurance.** \_\_\_\_\_ (initial)
- I understand my season pass is **NONTRANSFERABLE. I understand that in the event my season pass is used by anyone other than myself, ASC may assess and I hereby agree to pay an additional fee of up to \$500.** \_\_\_\_\_ (initial)
- Aspen Skiing Company season passes are valid on published opening dates and expire on published closing dates. The day prior to the scheduled opening day is reserved as a benefit for the Aspen Valley Ski Club on Aspen Mountain and season passes are NOT VALID on that day.
- I understand if the text on my pass or the picture is altered in any way, the pass will be void and, at minimum, I will be required to pay a \$5 replacement fee and I may be denied the privilege of replacing the voided pass.
- If I lose my season pass, I agree to report the loss to the ticket office immediately. I understand that a \$5 replacement fee will be charged. I also understand that if I find my pass, fail to report it to the ticket office, and it is pulled by an Aspen Skiing Company employee, it is my responsibility to pay a \$50 fee.
- I understand reckless or careless skiing/riding, neglecting to use ski-retention devices, line crashing, skiing/riding closed slopes or any closed areas, unloading from lifts at any place except regular stations, profanity, disorderly conduct, rowdiness, intoxication and use of drugs on the slopes, fraudulent use of tickets, collisions caused by my negligence, any theft or vandalism of ski area property, or violations of the Colorado Ski Safety act of 1979 as amended are among the offenses which are in violation of the area rules and regulations. I understand and accept all responsibilities that I have as a skier/snowboarder under the Colorado Ski Safety Act of 1979 as amended and the Skier's Responsibility Code.
- I understand I must have my season pass with me at all times while skiing/riding at Snowmass, Aspen Mountain, Aspen Highlands or Buttermilk, and that I must show it to any lift attendant, ski patroller, or other uniformed person upon request. If I forget my pass, I may be required to purchase a nonrefundable daily ticket at the current daily rate.
- Except while working for Ski & Snowboard Schools of Aspen/Snowmass, I agree not to engage in instructing skiing/snowboarding in any manner whatsoever, whether for pay in money, services, goods, or any other consideration, within the boundaries of any ski area operated by Aspen Skiing Company.
- I understand my season pass is a revocable license. I further understand that if I violate any of the above rules or any posted rules or regulations of Aspen Skiing Company, management may revoke my pass, and that my pass may be revoked without any refund and I may thereafter be denied the privilege of purchasing any form of an Aspen Skiing Company ticket or pass.
- I agree to reimburse Aspen Skiing Company for any expenses incurred by it in connection with any search or rescue that may be instituted because of my skiing outside the ski area boundaries or on closed slopes or remaining on the mountain after closing hours.
- In consideration of the issuance of a season pass to me, I agree to waive, release, indemnify, defend and hold harmless Aspen Skiing Company L.L.C., Aspen Highlands, L.L.C. and their officers and employees from and against any and all claims of any sort whatsoever arising out of or related to my use of the facilities, ski area and lifts at Snowmass, Aspen Mountain, Aspen Highlands and Buttermilk. I hereby assume all risks of skiing/riding.
- I intend and agree that the terms of this season pass agreement shall remain in full force and effect during every year hereafter in which I receive a season pass from Aspen Skiing Company.
- Venue for any claim arising out of the use of any Aspen Skiing Company property or facilities shall be proper only in the Pitkin County District Court.
- Comp and Conditional Comp Pass: I understand that if my employment terminates, I must turn in my pass and any dependent passes to my department head within 24 hours or the passes will be placed on the Pull List, and I will waive my rights to pursue any other Aspen Skiing Company pass for the season.
- College Pass: I am 24 years of age or younger and am currently enrolled in an accredited four-year college.
- In the event that I am signing on behalf of any minors, I have full authority to do so, realizing its binding effect on them as well as myself.
- If credit card payment, I authorize the charge.
- I, the undersigned, have read and understood the conditions of holding a season pass.
