THE PAST YEAR IN REVIEW

ANOTHER SUCCESSFUL YEAR FOR DEVELOPMENT

Generous alumni, parents, families, friends, foundations, businesses, and faculty and staff contributed over \$750,000 in the fiscal year 2009-10, ensuring that Colorado Rocky Mountain School was meeting its mission of cultivating a learning environment in which students discover their potential to excel. In all, 808 donors made a total of 1,428 gifts to all CRMS funds.

2009-10 ANNUAL FUND SURPASSES GOAL

The Annual Fund goal for 2009-10 was \$500,000, the highest in the school's history. The Development Office staff and the Board of Trustees along with alumni, parent, and student volunteers raised a total of \$507,193 in the *Vital to Our Success* Annual Fund campaign. This total was comprised of \$405,206 in unrestricted Annual Fund gifts, and \$101,987 in restricted Annual Fund gifts. Among the restricted gifts were \$9,001 in Scholarship Work Day proceeds.

PARTICIPATION IS KEY

Participation rates are key to an independent school's success in raising funds. High participation rates send a strong message to major and foundation donors that the school's constituents value the education being provided. Participation rates for the 2009-10 Annual Fund were:

- Board of Trustees 100%
- Faculty and staff 71%
- Current parents 50%
- Alumni 18%
- Parents of alumni 9%

SPECIAL EVENTS – PARENTS SUPPORTING COLORADO ROCKY MOUNTAIN SCHOOL

The *Roots Scholarship Silent Auction* was another financial success. Proceeds from this event (sponsorships plus sales) were the highest they have ever been. The event netted \$44,481 for scholarships for CRMS students.

Telluride Mountain Film on Tour was also a success, with net proceeds (sponsorships, ticket sales, and concessions) of \$5,142.

CAPITAL GIFTS SUPPORT CAMPUS UPGRADES

Capital Fund gifts totaled \$164,134. Over \$80,000 of these donations supported capital improvements to the glassblowing studio, forge, garden program, and dorms, in addition to over \$80,000 towards the new upcoming Capital Campaign, *Forging the Future // Preserving the Past*.

ASSURING THE FUTURE CAPITAL CAMPAIGN

Pledge payments for the 2002-05 *Assuring the Future* Capital Campaign totaled \$36,045 in 2009-10. This brings the total raised in that campaign to \$4,945,333. These funds were used to build the Jossman classroom building and to renovate the historic CRMS Barn.

ENDOWMENTS

Colorado Rocky Mountain School has more than 35 endowment funds that have been started and built over the years by donors who wanted to ensure that funding would always be in place for the school. Endowment donations totaling \$30,208 were received for seven endowment funds in 2009-10.

IN-KIND DONATIONS

A wealth of in-kind gifts were donated to CRMS in 2009-10. Gifts included more than 300 items for the *Roots Scholarship Silent Auction*, furniture, art, sports equipment and bikes, computer equipment, and much more.

ALUMNI EVENTS

A number of successful and well-attended alumni events took place in 2009-10. These included the Alumni Reunion on campus in February in conjunction with Founders' Day and alumni receptions held in New York, Washington, and San Francisco, as well as the annual Friday Night of the Fair gathering at Ella during Mountain Fair and the holiday gathering at The Lift, which were both held right here in Carbondale.

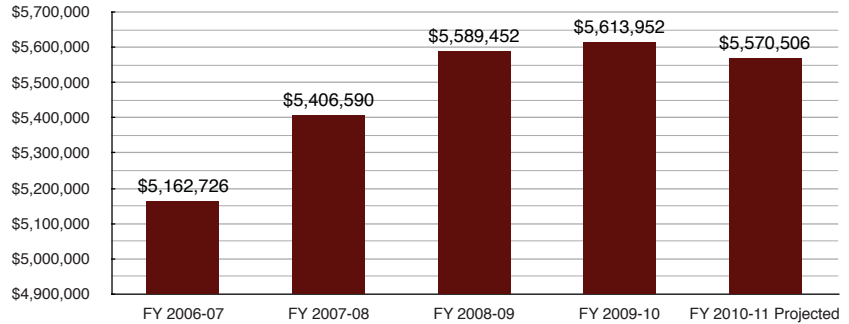

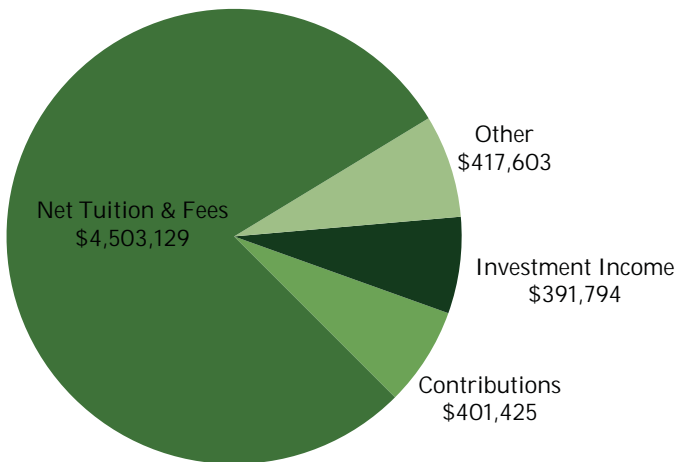

Annual Budget

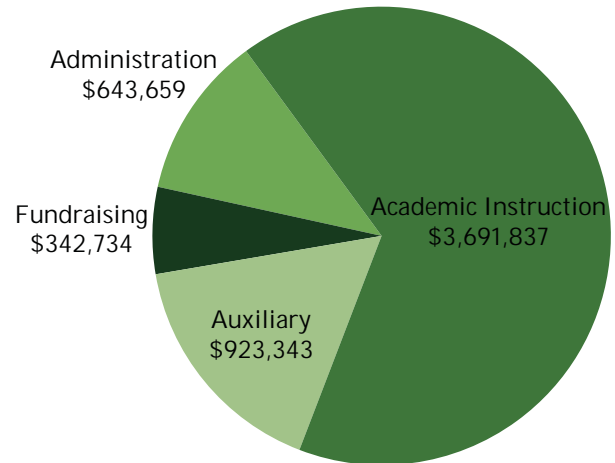


Actual Expenditures FY 2006-2010 / Projected FY 2010-2011

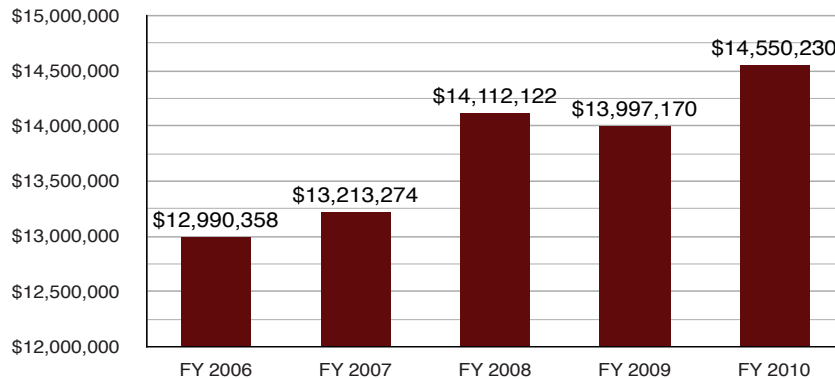
Revenues

Net Assets

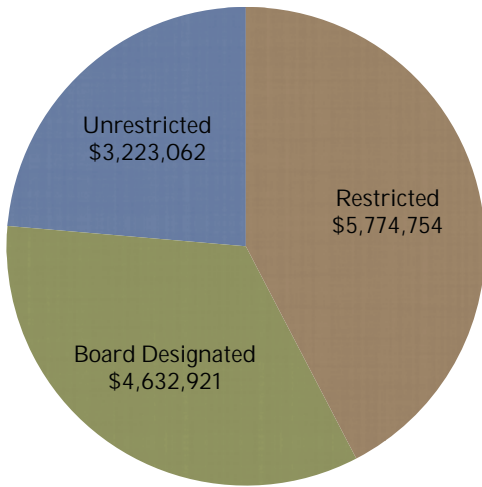




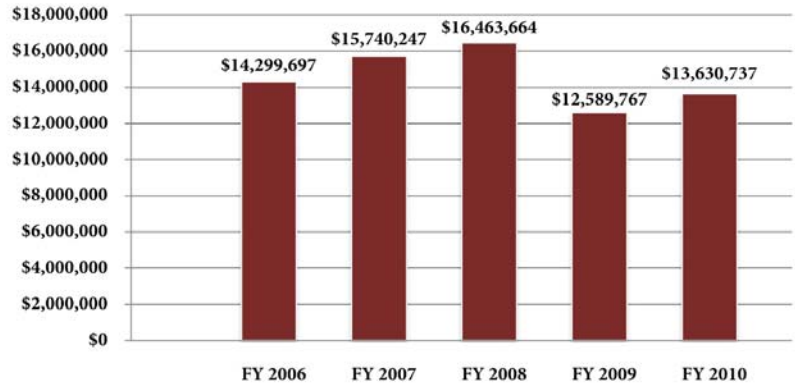

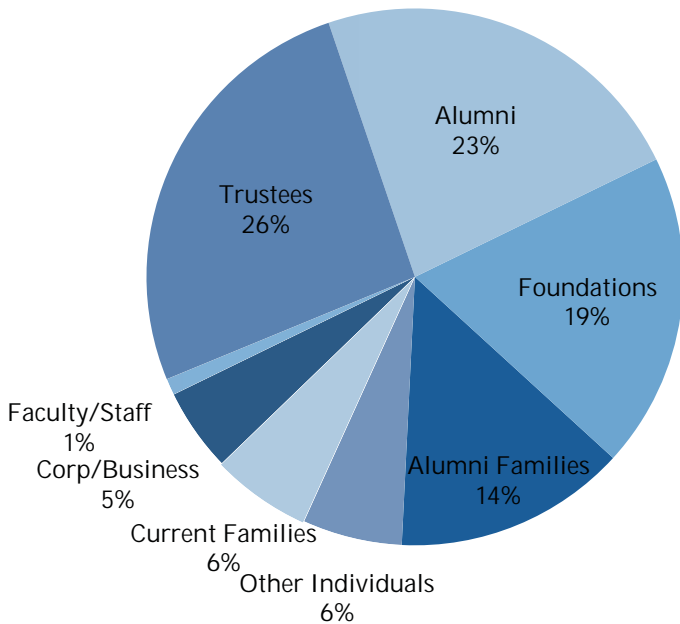
Endowment Fund Summary



Endowment Growth



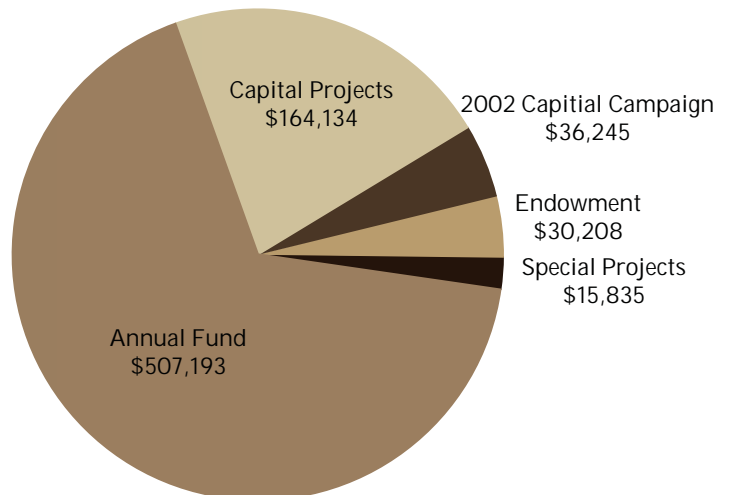
Gifts By Donor Type
