

Leave a Legacy

The Holden Circle recognizes and honors all individuals who designate support for CRMS in their wills, trusts, retirement plans, life insurance designations, and other planned gifts. By joining those who have already taken this step, you can have great satisfaction knowing that you are part of an important legacy supporting future generations of CRMS students.

Supporting CRMS through planned giving can optimize the donor's financial, tax, and estate plans, while contributing to the long-term financial security of the school.

Planned Giving

Planned giving involves providing for a future gift to CRMS through your financial and estate plans. The school welcomes gifts made through different planned giving arrangements. These arrangements can:

- Provide for you or your loved ones
- Entitle you to charitable income and/or gift or estate tax deductions
- Enable you to leave a legacy for CRMS

Planned Gifts can be simple such as bequests and beneficiaries or more complex such as Life Income Gifts. We are highlighting the simple ways you can support CRMS through a meaningful and impactful legacy gift.

Bequests

Bequests are the most popular type of planned gifts. Anything you leave to a charitable organization will reduce the size of your taxable estate while supporting a cause close to your heart. A bequest is simply a gift from your estate—a transfer of cash, securities, or other property made through your estate plans. You can make a bequest to CRMS by including language in your will or living trust leaving a portion of your estate to the school. This can be accomplished by specifying a specific sum of money or by leaving a percentage of your estate or residue after you have make provisions for family and friends.

Beneficiaries

Alternatively, you can designate CMRS as a beneficiary of a retirement plan or life insurance policy. Many people have accumulated a great deal in retirement assets (IRAs, 401Ks and other retirement plans) that have grown in value over the years. While there are tax implications to an individual beneficiary, a qualified charity like CRMS receives the full benefits. Likewise, you may simply name CRMS as a partial or whole beneficiary of a life insurance policy that is no longer needed and enjoy attractive tax benefits all while ensuring a future gift to the school.

Other beneficiary options including designating CRMS as a whole or partial beneficiary of a Charitable Remainder Trust, please consult your financial advisor for additional information.

In order to include CRMS as a beneficiary, contact the retirement plan administrator or Life Insurance Company and simply complete the appropriate beneficiary designation form.

For gifts that will take effect after your lifetime, CRMS should be named in your will as: "Colorado Rocky Mountain School, Inc., a nonprofit corporation, organized and existing under the laws of the State of Colorado, and with the principal business address of 500 Holden Way, Carbondale, CO 81623."
